# PROCEDURE FOR TYPE APPROVAL OF RADIO COMMUNICATION EQUIPMENT

### 1. SCRA is Responsible for Type Approval

SCRA (the Authority) is the regulator for the broadcasting and electronic communications in Seychelles and has a statutory mandate under the Communication Act, 2023 (Act 3 of 2023) (Act) to manage and regulate any matter relating to radio frequency spectrum. In light of this mandate, the Authority is responsible to ensure that radio frequency spectrum is managed in an efficient and rational manner and to ensure that there is no harmful interference to essential radio communication services. One of the responsibilities of the Authority is the type approval of radio communication equipment.

## 2. Purpose of Type Approval

The primary purpose of type approval is to ensure that radio communication equipment to be used/placed in the market in Seychelles comply with the relevant recognized international standards that are applicable in Seychelles. Type approval also ensures that the operating frequency/frequencies of radio communication equipment is in conformance with the National Frequency Band Plan<sup>1</sup> of Seychelles and minimize instances of interference between radio communication services. Furthermore type approval of radio communication equipment ensures the protection of health and safety of persons when operating the equipment and also ensures an adequate level of electromagnetic compatibility for the equipment.

The type approval in Seychelles is only applicable to radio communication equipment (telecommunication equipment with a radio frequency module). This procedure does not cover the importation of radio communication equipment covered under the Customs Management (Prohibited and Restricted Goods) Regulations, 2023<sup>2</sup>.

## **3.** Applicability and Procedure

The Authority's procedure for type approval is applicable to radio communication equipment only, including receive only devices. Telecommunication equipment with no integrated radio frequency module are not covered under this procedure. The procedure for type approval only involve the submission of relevant documents, indicated under section 5, so as to allow the Authority to assess compliance to the necessary recognized international technical standards namely those of the European Telecommunications Standards Institute (ETSI) and/or Federal Communications Commission (FCC) rules and regulations. As such, there are no tests done for the equipment. If the submitted documents show proof that the equipment conforms to the aforesaid international technical standards, then they will be accepted for usage in the Seychelles. Therefore, applicants must provide the necessary documents obtained either from the manufacturer or accredited independent test houses or laboratories confirming that the equipment complies with the necessary aforesaid international technical standards. Upon successful type approval of a particular equipment, the Authority issues an authorisation letter advising that the equipment is accepted for usage in Seychelles.

### 4. Fees

It is a requirement to pay, per equipment to be typed approved, the type approval fee in order for the Authority to process the type approval application. Depending on the currency that the applicant decides to use the fee to be paid are as indicated below. The banking details for the payments are placed at Annex 1.

- a. USD payments USD 45 per equipment
- b. EUR payments EUR 40 per equipment
- c. **GBP payments** GBP 35 per equipment
- d. SCR payments SCR 600 per equipment

The applicants must pay for all banking transaction fees so that the amount received is equivalent to the fees indicated above. In the event that the exact amount is not received the Authority will not process the application until the type approval fee is paid in full.

The Authority does not issue an invoice to applicants in order to initiate the type approval payments as this official document is the proof for the requirement to pay the fees indicated in this section. The confirmation of receipt of payment will be indicated in the authorisation letter.

### 5. Required Documents

In order to process the request for type approval and determine if the equipment can be accepted for usage in Seychelles, kindly submit the following documents to the address indicated under section 16.

- a. A formal letter requesting whether the equipment can be operated in Seychelles;
- b. If the application is being made on behalf of a manufacturer/company, please provide a signed copy of the "Power of Attorney" from the manufacturer granting authorisation for your company to obtain type approval on its behalf;
- c. Technical brochure containing a general description of the equipment and full technical specifications, including operating frequency, maximum transmit power and/or EIRP<sup>3</sup> and channel spacing of the equipment;
- d. Declaration of Conformity to recognized technical standards of the equipment issued by the manufacturer in respect to:
  - i. Radio Frequency Spectrum
  - ii. Electromagnetic Compatibility (EMC)
  - iii. Health and Safety;
- e. Test Reports of the equipment issued by the manufacturer or accredited independent test houses or laboratories in respect to:
  - i. Radio Frequency Spectrum
  - ii. EMC
  - iii. Health and Safety; and
- f. Proof that payment has been made in the form of a remittance advice.

The Authority may also request for additional information if required to assist in processing the request.

### 6. Declaration of Conformity

Declaration of Conformity is a document by which a manufacturer gives written assurance that the radio communication equipment conforms to recognized international technical standards to which the equipment is in compliance to, namely ETSI and/or FCC rules and regulations, related to Health and Safety, EMC and Radio Frequency Spectrum. The Declaration of Conformity can be in the form of a signed certificate or a signed letter issued by the manufacturer with a list of standards.

### 7. Test Reports

Test reports can be done by the manufacturer or accredited independent test houses or laboratories. The Authority accept test reports from all accredited independent test houses or laboratories and we do not have a list of authorised accredited independent test houses or laboratories that can issue test reports. All test reports should be signed and dated. Test reports issued by the manufacturer or accredited independent test houses or laboratories for the equipment must be in respect to Health and Safety, EMC and Radio Frequency Spectrum.

### 8. Modifications To Type Approved Equipment

The applicant must re-submit all relevant documents to the Authority, and follow the same process indicated under section 5, in the event that a previously type approved equipment is modified with respect to following:

- i. The brand and/or equipment name, model and function recorded by the Authority;
- ii. There are changes to the operating frequency and maximum transmit power and/or EIRP of the equipment; and
- iii. The recognized technical standards to which the equipment was type approved has changed.

### 9. Modular and Family Authorisation/Certification

Both modular and family authorisation/certification is allowed under the Authority's type approval procedure. Modular authorisation covers the type approval of the radio frequency module integrated in a host device (specific model of equipment). As such, the authorisation granted by the Authority under section 3 of this procedure for a radio frequency module allows for all host devices which has the said radio frequency module integrated to be placed on the market in Seychelles without having to test or certify the host device e.g. the Wi-Fi card installed in a laptop is the radio frequency module and the laptop is the host device.

Family authorisation/certification covers the type approval of group of host devices (different models) that are part of the same series or family of equipment. In this scenario the group of host devices are type approved under just one process instead of a request for each host device/model. The different host devices needs to have the same integrated radio frequency module and are to be related only in terms of cosmetic (including, for instance, colour, external design, enclosure etc.).

Notwithstanding the above, for modular and family authorisation the documents required under section 5(a), (c) (d) and (e) should clearly indicate the following:

- i. That the host devices uses the same radio frequency module; and
- ii. The different host devices to be type approved are part of the same series or family and use the same radio frequency module.

Please note that only one payment of the type approval fee indicated under section 4 is required for equipment to be type approved under modular and family authorisation.

### **10. Certificate Owner**

The authorisation letter issued by the Authority is to grant permission for the radio communication equipment to be used in Seychelles; and it is usually issued to the entity making the type approval application regardless if it is the manufacturer of the equipment or another entity delegated to do so on behalf of the manufacturer.

#### 11. Compliance with the Recognized International Technical Standards

Even if a radio communication equipment is already in compliance with the necessary international technical standards namely ETSI and/or FCC rules and regulations, the equipment is still required to be type approved before importation in Seychelles. Application for type approval must not be made for radio communication equipment not complying with the necessary aforesaid technical standards.

### **12.** Type Approval is Mandatory

Type approval of radio communication equipment is mandatory in Seychelles.

### **13. Processing Time**

It will take typically fourteen (14) working days to process the application provided that payment has been received and all the necessary documents have been submitted to the Authority. Please note that even if the proof of payment mentioned under section 5(f) has been submitted, the Authority will only issue the authorisation letter once payment has been confirmed internally.

#### 14. Labelling Requirements

There are no special labelling requirements in Seychelles, but it is to the manufacturer's benefit to label its equipment to indicate the associated standard(s) to which it complies and which reflects our regulatory policies and guidelines, such as the ETSI and/or FCC rules and regulations.

This will prevent any unforeseeable delays and complications during the authorisation and/or importation.

#### 15. Validity

There is no duration of validity for the authorisation to be granted under section 3 provided that no modifications have been made for the type approved radio communication equipment as mentioned in section 8.
